II. ITEMS OF GENERAL DISCUSSION:

Performance Enhancing Drug consent form needs to have the IHSA language included on the school form or the exact document the IHSA provides.

The excel form that is provided for student-athlete tracking is one option to tracking student-athletes. The general requirement is that an electronic form must be readily available to send to Drug Free Sport when requested from them prior to do testing.

Is it possible to review the policy of a player ejection in football for unsportsmanlike (fighting) considering the availability of video?

There is concern that Soccer officials are out of control with showing cards. Officials can't verify a reasoning for an ejection of a fan. The number of cards is outrageous and the physicality of soccer has gotten to a different level.
