<b>6. By-law 2.090</b> Season limitations provided to all staff		
<b>7. By-law 2.120</b> Required rules interpretation meeting		
<b>8. By-law 2.130</b> Attendance at required Principals meeting		
<b>9. By-law 2.150</b> Physical exam requirement		
<b>10. By-law 2.170</b> Student-athlete/parent PES program sign-off Coaches completed PES education program		
<b>11. By-law 3.010 &amp; 4.010</b> Attendance requirement by all students (including home schooled)		
<b>12. By-law 3.020 &amp; 4.020</b> Scholastic standing 25 credit hours weekly and 25 credit hours for the semester

<b>14. By-law 3.040</b> Transfer requirements checked on all transfers and proper paper work filed for a ruling by IHSA on students that do not meet requirements

<p><b>16. By-law 3.060 &amp; 4.040</b> Age requirement checked on all participants (through the age of 19)</p>		
<p><b>17. By-law 3.070</b> Recruiting by-law explained to all staff and how rule is monitored by your school</p>		
<p><b>18. By-law 3.100</b> Independent team participation reviewed with staff and students</p>		
<p><b>19. By-law 3.110</b> Coaching school participation reviewed with all staff and how it is shared with students (camps, clinics, and lessons during the school year and the difference for the summer)</p>		
<p><b>20. By-law 3.120</b> All-star participation</p>		
<p><b>21. By-law 3.130</b> Use of only eligible students and practice with only bona fide students from your school</p>		
<p><b>22. By-law 3.150</b> Summer provisions—25 contact days, method of tracking this</p>		
<p><b>23. By-law 5.000</b> Limitations of number of contests and any individual limitations for each sport</p>		
<p><b>24. By-law 6.011 &amp; 6.012</b> Player/coach ejections—method of tracking and who handles this to make sure penalty is administered</p>		
<p><b>25. Return to Play (RTP) Policy</b> Reviewed with all coaches and concussion sign-offs collected for all students before student participation (practice)</p>		
<p><b>26. Fall Sport Acclimatization Policy 38</b> Reviewed with all fall sport coaches with the exception of Boys and Girls Golf.</p>
